## As a result of education in the specialty "Law" you will receive the next professional competencies:

- knowledge acquirement and understanding of the features, key concepts and principles of the legal system, including the European and international dimension (including institutions and procedures), legal principles and values, which are the subject of an advanced core educational course;
- using of professional knowledge in the branches of law: constitutional, municipal, criminal, civil, family, labor, housing, land, agricultural, environmental, economic, administrative, financial and others; in criminology, forensic science, judicial medicine in the field of international legal relations to protect constitutional human rights and freedoms and the citizen or the provision of advice and clarification, the resolution of other issues arising in specified areas;
- keeping records, drawing up draft transactions, including contracts, acts, applications (including claims), complaints (including appeals and cassation), notarial, local regulatory and other documents of a legal nature;
- participation and representation in court hearings on criminal, civil, economic and administrative cases in all courts;
- study, analysis and assessment of the circumstances of the case, interpretation and correct application of the norms substantive and procedural law, the implementation of the correct legal qualifications, the adjudication of the case in accordance with the current legislation;
- application of modern working methods in solving legal issues, acquisition of working skills with modern equipment, electronic databases of regulatory acts, official electronic registers.

- scientific activities in the field of law;
- teaching in the field of law;
- advocacy;
- advices on legal protection;
- pre-trial investigations;
- the implementation of justice;
- management in the areas of financial and tax activities;

Finishing graduate school and holding Ph.D. degree in specialty 081 "Law" allows you to work in research institutions and institutions of higher education, as a judge of Constitutional Court of Ukraine, as judges of appeal and cassation instances, as a lawyer, as a lawyer in the Office of the President of Ukraine, as a lawyer in the central executive bodies, as an employee of General Prosecutor's Office of Ukraine, as human rights defender in the Secretariat of the Commissioner Human Rights of the Supreme Council of Ukraine or continue doctoral studies.
