- Cost of publication is 250 UAH (20 USD for foreign participants). The registration fee includes: a publication of materials, sending one copy of the published conference abstracts to the author and issuance of the certificate.

1. *Development of firms in the context of strategic changes.*
2. *Formation of the development strategies for the regions of Ukraine in the conditions of European integration.*
3. *Strategic priorities of a state in the conditions of the institutional changes.*
4. *Demography, labour economics, social economics and policy.*
5. *The financial system of Ukraine: the institutionalization of development in the conditions of globalization.*
6. *International economic relations in the conditions of the institutionalization and global convergence.*
7. *Mathematical methods, models and information technologies in economics.*

Working languages of the conference: Ukrainian, Russian, English.
