2. Purpose and objectives of the discipline

The purpose of the discipline is to provide students with systemic knowledge as to the place and role of the Islamic factor in domestic and foreign policies of the countries of Islamic civilization, as well as in the international relations in general.

The objectives of the discipline: to study the place of the Islamic factor in world politics through the prism of political processes occurring in the countries of the traditional area of Islam and Islam as the dominant religion (the Middle East, Southeast Asia, Central Asia, etc.) as well as with a strong Muslim community (Russian Federation, Western Europe and Tropical Africa); to explore the history of Islam and the formation of Islamic civilization; to identify the main reasons for politicization of Islam in the XX century; to analyze the influence of the Islamic factor on political decision-making in Muslim countries; to study the activities of international Islamic organizations; to discover the origins and evolution of the problem of Islamic fundamentalism; ideology and activities of radical Islamist organizations.

The process of studying the discipline is aimed at forming elements of the following **competencies**:

- 1. Ability to identify, formulate and solve problems (ZK 3).
- 2. Ability to work in an international context (ZK 6).
- 3. Ability to make informed decisions regarding international and foreign policy activities (SK 2).
- 4. Ability to justify the choice of ways to solve professional tasks in the field of international relations, public communications and regional studies, critically evaluate the results obtained and justify the decisions made (SK 3).
- 5. Ability to identify and analyze the features of the development of countries and regions, modern global, regional and local processes, and Ukraine's place in them (SK 9).

- Identify, assess and predict political, diplomatic, security, social and other risks in the field of international relations and global development (RN 6).
- Assess and analyze international and foreign policy problems and situations, propose approaches to solving such problems (RN 7).
- Participate in professional discussions in the field of international relations, foreign policy, public communications and regional studies, respect opponents and their points of view, convey information, ideas, problems, solutions and own experience on professional problems to specialists and the general public (RN 13).

3. The content of the discipline

CONTENT MODULE I. ISLAM AS A WORLD RELIGION. THE PHENOMENON OF POLITICAL ISLAM.

Topic 1. The role of Islam as a world religion.

The increasing role of religious factor in domestic and foreign policy of states and in international processes in the beginning of the XXI century. Formation of a post-secular society and the place of Islam. Origins of Islamic culture and civilization. Sharia as a set of legal, moral, ethical and religious norms of Islam. The emergence of different religious and political trends in Islam. Sunni and Shia Islam. The geography of Islam and Muslim communities in different regions and countries (the Middle East, the South and Southeast Asia, Sub-Saharan Africa, Europe, North America). The main factors behind the growth of Muslim population and the influence of Muslim countries. The concepts of "Muslim civilization" and "Muslim world". Islam in the new geopolitical realities.

Topic 2. The phenomenon of political Islam.

The features of the Islamic religious system. The universal role of Islam in the Muslim society. Islamic political culture and ideology. The ideas of power and property in Islam. The image of the ruler as the stronghold of Islam and the guarantor of the community. The specifics of the Muslim statehood. The role of clergy in the Muslim society. Relations between religious and political institutions and actors. The reasons for the politicization of Islam in the XX century. Islam as an instrument of state power. Non-governmental Islamic political organizations. The role of political Islam in confessional and ethnic conflicts. Islam and democracy. The place of political Islam in the context of the Arab Spring.

Topic 3. The Islamic world as a subject of world politics.

The concept of Ummah. The processes of integration in the Muslim world and examples of political consolidation of Muslim communities. Doctrine of pan-Islamism. The Organization of Islamic Cooperation (OIC): history of creation, main tasks, principles of work and directions of activity. Substructures of the OIC. International Muslim organizations: D-8, the Islamic Development Bank, The Islamic Educational, Scientific and Cultural Organization, the Islamic Solidarity Sports Federation, the Islamic Chamber of Commerce, Industry and Agriculture. Muslim solidarity and its limitations. Contradictions that divide the Muslim world (Sunni-Shiite confrontation; differences in economic development; territorial and ethnic conflicts. etc.).

Topic 4. The problem of Islamic fundamentalism and extremism.

Traditionalism, fundamentalism and modernism in Islam. Genesis and development of Islamic fundamentalism (H. al-Banna, S. Qutb, A.A. Maududi); its evolution in the XX – the beginning of the XXI centuries. Moderate and radical fundamentalism. Differentiation of the conceptual apparatus: "Islamic fundamentalism", "Islamic extremism", "Islamic terrorism", etc. The spread of radical Islamist ideology in the countries of Islamic civilization. Ideological platform and activities of radical Islamist groups. The impact of the events of September 11, 2001, on the transformation of the role of Islamic extremism in contemporary international relations. Approaches of international organizations and global players toward the problem.

CONTENT MODULE II. THE ISLAMIC FACTOR IN THE MIDDLE EAST. Topic 5. The Arab countries of the North Africa.

Political Islam in Egypt: stages of development. Muslim Brotherhood: an ideological platform and activities. Relations between the state and radicals in Egypt. Problems of Muslim-Coptic relations. Political Islam in Libya. Incorporation of Islamic elements into the ideological and political system of the country in the era of Gaddafi. Islamic socialism. The Islamic factor in Egypt and Libya after the revolutions in 2011. Islamic radicalism in Algeria. The Islamic Salvation Front and the civil war in the 1990s. The role of political Islam in Algerian society.

Topic 6. The Arab countries of the West Asia.

The Arabian Peninsula and the birth of Islamic civilization. The leading role of Islam in the political, socio-economic and cultural life of the Persian Gulf monarchies (Saudi Arabia, Qatar, Oman, UAE, Kuwait, Bahrain). Saudi Arabia as the center of the Sunni Muslim world. Wahhabism in Saudi Arabia. The Islamic factor in Iraq: Sunni-Shiite contradictions and its evolution after 2003. The problem of Islamic radicalism in Syria after the outbreak of civil war in 2011. The phenomenon of the Islamic State (IS) in Syria and Iraq. The Islamic factor in Lebanon. The civil war (1975-1990). The role of Hezbollah. Sunni-Shiite contradictions in Yemen.

Topic 7. Turkey, Iran, Afghanistan.

The concept of "laicism" (secularism) in Turkey and its evolution in the 20th century. The Islamic factor in Turkey's domestic and foreign policy in the 1990s. The Justice and Development Party (from 2002). Shiite doctrine in Iran. The Islamic revolution in 1979 and the role of Khomeini. Formation of a unique Islamic political system in Iran; "the export of Islamic revolution". Islamic traditionalism in Afghanistan and its fundamental role in Afghan society. The Taliban regime in the 1990s. Al Qaeda: ideological concept and terrorist activity. The events of September 11, 2001 in the United States and the war in Afghanistan (2001-2015). Islamist resistance in the country nowdays.

Topic 8. The role of the Islamic factor in regional conflicts in the Middle East.

Religious aspect of the Arab-Israeli conflict. Role of Palestinian radical groups: Hamas, Islamic Jihad and others. Israel's military operations against Hamas. The war between Israel and Hezbollah (2006). Sunni-Shiite contradictions and their impact on regional processes: Iran-Iraq War (1980-1988); Shiite protests in Bahrain (2001); The Houthi movement in Yemen. Rivalry between Saudi Arabia and Iran as Sunni and Shiite centers of power. The role of radical Islamists in the civil war in Syria (2011-2019) and in the war in Afghanistan (2001-2014). The Islamic State (IS) and its impact on regional stability.

Unsatisfactory with mandatory repeated study of the discipline

does not display knowledge of the educational material.

performs only elements of the task, needs constant help from the instructor.
